This is with reference to your proposal no. IA/CG/IND1/455965/2024 dated 30.01.2024 by M/s. Seeta Energen Private Limited requesting the Ministry to transfer the Environment Clearance accorded by MoEF&CC vide EC identification no. EC23A008CG110697 (F. No. J-11011/347/2017-IA.II(I)) dated 07.11.2023 as mentioned above from M/s Real Power Private Limited to M/s Seeta Energen Private Limited.

3. The Ministry of Environment, Forest and Climate Change (MoEF&CC) has examined the request submitted by you and the following points are noted:

i. The Environment clearance (EC) to the project cited above was accorded by the Ministry vide EC identification no. EC23A008CG110697 (F. No. J-11011/347/2017-IA.II(I)) dated 07.11.2023 Establishment of 1 x 9 MVA Ferro Alloys plant (Silicon Manganese-14400 TPA or Ferro Manganese-25200 TPA or Ferro Chrome-15000 TPA or Ferro Silicon-7000 TPA or Pig Iron -25200 TPA) in existing 7.5 MW Biomass based Power Plant premises (Forward Integration) in existing plant premises by M/s M/s Real Power Private Limited, located at Khamhardih Village, Pathariya Tehsil, Mungeli District, Chhattisgarh.

ii. No Objection Certificate (NOC) dated 30.01.2024 from transferor i.e., M/s Real Power Private Limited in a non-judicial stamp paper for transfer of environmental clearance letter dated 07.11.2023 from M/s Real Power Private Limited to M/s Seeta Energen Private Limited has been received.

iii. The undertaking Dated 30.01.2024 by transferee i.e., M/s. Seeta Energen Private Limited in a non-judicial stamp paper has been received stating/committing that the company (M/s. Seeta Energen Private Limited) agrees for the transfer on the same terms and conditions under which prior Environmental Clearance was initially granted as per the provisions of EIA notification, 2006 in favour of M/s. Real Power Private Limited.

iv. As per information provided by the PP, the Corporate Identification Number (CIN) of M/s Real Power Private Limited and M/s Seeta Energen Private Limited are same i.e. 27109CT2004PTC016578. The name of the company has been changed from Real Power Private Limited to Seeta Energen Private Limited. The shares and directors (promoters) of the company have been also changed. Further, the has mentioned that there is change of Ownership.

4. As per Ministry's OM dated 03.11.2023, the PP has submitted the CTO in the name of transferee.

5. **Reason for EC Transfer:** The PP has informed that M/s. Real Power Private Limited has been taken over by M/s. Seeta Energen Private Limited. The ownership/ Directors (promoters) of the company has been changed and therefore EC transfer is needed to reflect the authority of the new management and for branding purpose.

6. The matter has been examined in the Ministry and in view of the above, it has been decided by the Ministry to transfer the Environmental Clearance granted vide EC identification no. EC23A008CG110697 (F. No. J-11011/347/2017-IA.II(I)) dated 07.11.2023 in respect of "Establishment of 1 x 9 MVA Ferro Alloys plant (Silicon Manganese-14400 TPA or Ferro Manganese-25200 TPA or Ferro Chrome-15000 TPA or Ferro Silicon-7000 TPA or Pig Iron -25200 TPA) in existing 7.5 MW Biomass based Power Plant premises (Forward Integration) in existing plant premises, located at Khamhardih Village, Pathariya Tehsil, Mungeli District, Chhattisgarh", from M/s Real Power Private Limited to M/s Seeta Energen Private Limited, subject to satisfactory compliance to all the stipulated specific and general conditions .

7. M/s Seeta Energen Private Limited shall comply with all the specific and general conditions stipulated in the Environmental Clearance granted to M/s Real Power Private Limited vide EC identification no. EC23A008CG110697 (F. No. J-11011/347/2017-IA.II(I)) dated 07.11.2023. All other conditions stipulated in the Environmental Clearance letter dated 07.11.2023 shall remain the same.

8. In case, there is a change in the scope of the project, fresh environmental clearance shall be obtained.

9. This issues with the approval of the Competent Authority.
